-Since WTICDA has low activity at this time, does WTICDA's financial statements count for the PADCED requirements? Determination of this will need to be made. -Jenn stated that IDA requires an audit. Previous audit cost approximately \$4,000.

-Kent will ask Vito to determine from PADCED if an audit is required.

-PADCED's response will need to be issued in writing.

-Kent? will inquire if the same auditor that does Whitehall Township's audits can also do WTICDA's audit (if required). This audit will be completely separate from the Township audit, the request is only to use the <u>same</u> auditor.

-Lee Rackus said that requests on land development are including requests for charging stations, Interest from developers is there, but stations have not been forth coming -Lee said that developers said that every square inch of lot is valuable, which is why chargers have been slow to come. Recent L&L legislation last year was made to modify size of lots. May help encourage EV Chargers
