Mayor's Message

When I was appointed by the Board of Commissioners in April of 2018, I asked the individual Board members to compile their list of priorities for the Administration. Every member included a new Public Safety building at, or near, the top of their list. In 1993, the Police Department was moved from their offices in the Municipal Building to a property on Lehigh Street acquired from the Whitehall Ambulance and Rescue Corps and it was retrofitted to accommodate a smaller police force than our current force.

On my first weekend in office, I was contacted by Police Chief Mike Marks who told me that there had been a power surge in the building that had compromised the electrical service to the site. Along with stories of the basement of the building needing a lifeguard after any significant rainfall, incited me to get after a replacement as soon as possible.

I sat down with Deputy Mayor Jack Meyers and our Department heads and we began to move forward with a plan to have a project to the Board before the end of the year. We engaged D'Huy Engineering, Inc. located in Bethlehem, to assist us along with KCBA Architects of Hatfield, Bucks County to design the project. We reviewed the previously compiled information and quickly moved to evaluate any potential location that might work as a new home for our first responders. After our evaluation, we determined that a relocation to the existing Municipal complex was optimal. We decided to coalesce our public services in one structure that would be able to serve our residents more effectively.

During the summer of 2018, our staff and advisors met regularly to determine needs for our departments located in the Municipal and an auxiliary Public Works building. We determined that a single "transaction" area was best able to serve needs of residents. Those wishing to pay bills or obtain information will be able to see our Receptionist, Treasurers, Recreation, Development departments and will have separate and more private locations to interact with our staff. Visitors will be able to gain access to the Police Department in a

reception area for information that will control entry to a secure area if necessary.

D'Huy and KCBA presented a plan to the Board of Commissioners in October that was approved funding for design of the project in December of 2018. We opened bids for a \$10 million bond issue that will fund the initial phases of construction and anticipate funding the rest of the project soon. With the assistance of our State Representatives McNeill and Mako and Senator Boscola we have received a \$1 million State Grant to help defray costs. We are seeking additional sources to acquire additional grants.

Throughout 2019, we continued to meet with D'Huy and KCBA to cut costs and provide the information necessary to design an economic building, cutting over \$8 million out of the original format plan. The Board ultimately approved a final design of a \$17.5 million plan which will fund a new Public Safety Building and provide for necessary improvements to the existing Municipal Building. The structure is intended to provide space for the next 40 – 50 years.

RETIREMENTS

2020 started with a few notable retirements as follows:

Officer Michael Arnold

Officer Arnold is retiring as the most decorated officer to ever serve this township. He has received eleven medals for meritorious service during his twenty-five year career. Officer Arnold was assigned many different tasks over his career at the Whitehall Police Department. He was a founding member of the Bike Patrol unit, was the leader of the warrant service unit, served in the capacity of acting supervisor numerous times and served the department as a field training officer. Mike cared about the people he trained and it showed when they hit the street on their own. Officers

COMMUNITY NEWS

Whitehall-Coplay Communities That Care (CTC)

On January 23, the Whitehall-Coplay CTC together with the Catasauqua CTC held its annual breakfast hosted by Fellowship Community in the Zentz Community Center. Fifty-four people attended the breakfast sponsored in part by the Whitehall Area Rotary Club. The keynote speaker was Dr. Damon Jones of the Penn State Prevention Research Center. He spoke about the economic benefits of community coalitions that address reducing risk and increasing protection



for the community's youth. Dr. Jones talked about the impacts of the "developmental cascade" where life experiences such as hunger or family instability create a cycle where children fall behind in school and continue on a downward spiral. He applauded both coalitions for tackling food insecurity, mental health and substance use prevention as a community effort.

In addition to the speaker, awards were presented to a Community Champion from each coalition. Receiving the award for Whitehall-Coplay was Michelle Khouri, the school district registrar. She was recognized for her efforts in reaching out to all families in the community including those who are new and those who need support in navigating the school system for their children. She provides resources to families that extend beyond registering the children in the district. Michelle's work is an example of how a community works to stop the developmental cascade which the speaker described.

This summer, the Whitehall-Coplay CTC will be doing an extensive review of the 2019 PAY Youth Survey, better known as PAYS, which was administered to students in grades 6, 8, 10 and 12 this past fall. This tool enables us to see how the youth perceive their school, family, community and peer relationships so that we may all work together to create a safe and healthy environment in which they and their families can grow and thrive.

SNACK AND BATH PACK PALS – 53.67 % of the school district's student population qualifies for the free or reduced-price breakfast and lunch program. For the working poor, this program is a blessing. The students are in every grade K-12. Some of these children and young adults rely on the breakfast and lunch programs as their only source of nutritious meals. Leah Saliby, an 8th grade English teacher, oversees this in-school program.

For the 2019-2020 School Year, the program is on track to distribute approximately 45,000 food items in Snack Packs distributed to 230 students monthly. Many more students can be served, but Leah's storage space is filled to the maximum. Also, 5 students receive Snack Packs weekly in addition to the monthly distribution. Approximately 2,500 snacks will be donated to the Gockley Building (Kindergarten and 1st grade) this school year for 200 students who are unable to bring a snack to school because they do not have any. Snacks also are given to Middle School students who stay for extracurricular activities (not just sports – who also do not have any). They receive a granola bar and juice every Tuesday. The Middle School exact count is not available, but numbers in the hundreds yearly.

Thank you for all the food drives and business donations. Leah cannot do this program without your help and the donations given by Second Harvest Food Bank. If you would like to make a food donation, Leah urgently needs 8 oz. boxes of shelf-stable white milk, peanut butter to go packs, and small boxes of raisins. Also needed are: cheese/peanut butter cracker packs, small boxes or sealed bowls of cereal, macaroni & cheese (boxes & bowls), Chef Boyardee (cans & microwavable bowls), fruit & applesauce cups, fruit snacks, juice boxes/pouches, graham crackers, and granola bars.

Drop off locations for Snack Pack Pals are at the Whitehall and Coplay Public Libraries, the Whitehall Township Building, and Re/Max Unlimited Real Estate. Leah also thanks all the school clubs and the public volunteer support. Our 2nd site is at the Redeemed Church of God, 5 N 3rd St in Coplay. They had 43 registered campers and 1762 meals were served in 2019. By helping food insecure children, we help working poor parents stretch their hard earned income dollars!! We really need adult volunteers to help once, once a week, the whole summer – whatever your time allows. Please tell your friends, family, and co-workers about this very important summer program and invite them to come to help with the Camp. Free adult clearances are required. SENIOR BOXES – Free Food to help Seniors stretch their food budget dollars. Income caps are set by the federal government for seniors 60+ years old. What you receive is a monthly food box which includes 4 cans of vegetables, 2 cans of fruit, 2 bottles of juice, 1 peanut butter or beans, two cereals or one bag of oats, two pounds of pasta or rice, two shelf stable milk, one instant milk(six times a year), one meat, and one block of cheese. Items needed to register: verification of id, age and address i.e. driver's license, picture id card, birth certificate or similar document. Verification of family income: W-2, previous year's tax return, social security award letter, last four paystubs or similar documents. For more info call, John Orsini at 610-390-8833

WHITEHALL FOOD PANTRY – Every month the pantry serves 150 adults including 35 seniors and 115 children on average. Since we are in warmer weather, typical items needed include: iced & hot teas, lemonade, ground coffee, cereal, juice, pancake mix & syrup, 16 oz. jam & jelly, any kind of soup (other than tomato or chicken noodle), crackers & noodles for soup, canned beets, pea & carrots, spaghetti sauce, tuna, instant mashed potatoes, pasta/rice dishes, canned pasta, and hamburger/tuna helper. “Hockin Landing” Company Historic Preservation in Whitehall, PA

Here stands the remnants of what was once a thriving industrial complex, the former Thomas Iron Works or as many locals called the “company town.” For many residents that were raised in the area in the 1950s and 60s and beyond, they remember playing by the river in old buildings and tunnels.

Hokendauqua, taken from the Delaware Indian language word, “hockin,” meaning “landing” was a company town laid out in 1854 and constructed in 1868 to house the many employees of the Thomas Iron Works Company. The neighborhood featured about 100 factory homes built for workers during the 1880s, including the area from Front to Third Street and Quigg to Carbon Street. For many, these workers are family and the traditions of the community remain today.

With the goal to place the neighborhood surrounding the former Thomas Iron Works in Hokendauqua on the National Register of Historic Places, the Whitehall Township Board of Commissioners unanimously approved the Township’s preparation and submission of the state grant application by the Whitehall Township Industrial and Commercial Development Authority (WTICDA) to the Pennsylvania Department of Community and Economic Development for Local Share (LSA) funds. The effort began the process to engage the Pennsylvania Historical and Museum Commission (PHMC) to fund any other necessary steps to obtain approval under the National Register of Historic Places of the area known as and surrounding the Thomas

Iron Works neighborhood.

Later in 2019, with the help of state Senator Lisa Boscola, and Reps. Jeannie McNeil and Zach Mako, who represent Whitehall Township and the future historic district site, WTICDA was awarded the LSA funds through the Commonwealth Financing Authority. The grant will allow WTICDA to complete the application requirements required for submission to the United States Department of Interior for designation as a National Historic Site.

Prior to the state grant submission, residents were surveyed and the response to the efforts were overwhelmingly positive. Next steps under the grant include identifying which properties will be surveyed, hiring and training site surveyors, completing more surveys and preparing a report to PHMC and completing the planning grant requirements. All work will be done under the oversight of an Historian, Artefact, Inc., a professional architecture firm selected by the WTICDA Board in Jan. 2020 for professional services.

WTICDA will undertake significant grant matching fund development efforts for the PHMC planning grant and ultimately for the submission to the US Department of Interior for designation as a National Historic Site. To show support for this initiative, the WTICDA will match all individual contributions up to \$100 each through the end of the year 2020. The Whitehall Area Rotary continues our theme of *PEOPLE OF ACTION* into 2020. This past December we were exceptionally busy hosting two major activities: Jingle Bell Run/Walk and our newest endeavor, Pet Adoption Event. Our 3rd Annual Jingle Bell 8k Run/5k Walk was held on December 14th along the Ironton Rail Trail, commencing at the Coplay Saylor's Pavilion. One of our ongoing activities is the monthly distribution of the SUNShine Boxes, provided by Second Harvest Food Bank. SUNShine (Serving Under-Nourished Seniors) are distributed by volunteers on the 3rd Monday each month at St Stephen's Episcopal Church, Whitehall.

We are in the planning stages for these events for 2020: Rotarians will be volunteering their time to conduct the Spring Mock Interviews with Students at the Whitehall

High School. This biannual event gives the students an opportunity to practice interview skills and talk to professionals in a variety of businesses. Career Day, held in the Spring at Whitehall High School, is another way we connect Rotarians with the students to help guide them into the world beyond High School. Make A Difference is held annually to celebrate the creation of our current Whitehall Area Rotary. This year we are partnering with the American Red Cross on their Sound the Alarm, Save a Life event, April 25th. This event partners local fire departments, community leaders and volunteers to install life-saving smoke alarms and help families make emergency escape plans, so they'll know what to do when the alarm sounds in the middle of the night.

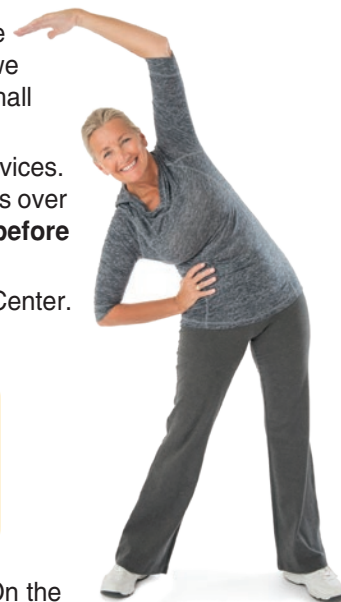

2019 STATE OF THE DEPARTMENT REPORT

The following is a broad review of police initiatives from calendar year 2019.

The Bureau of Police has grown to include a budgeted allotment of forty-nine (49) sworn officers and five (5) civilian support staff. The township is the second largest police department within Lehigh County. The current department staffing is currently at forty-six (46) officers with three vacancies. One (1) officer is on extended medical leave, as a result of a gunshot wound suffered in the line of duty. One (1) officer is on extended medical leave, as a result of an injury that occurred while taking a suspect into custody. One (1) officer is pregnant and assigned light duty status for the near future.

The Whitehall Police Patrol Division, including the Traffic Unit, is the backbone of the police department and according to Lehigh County Dispatch Data, responded to almost 22,000 calls for service in 2019. This was an increase of over 4,000 calls for service from the 2014 calendar year. The Patrol Division covers approximately 162 miles of roads in Whitehall Township on a daily basis, while serving the 27,714 residents, and an estimated 60,000 people who work or commute through the township.

The Patrol Division and Traffic Unit conducted an aggressive driving enforcement initiative that focused on reducing accidents along the MacArthur Road corridor and secondary streets. The Traffic Unit was created in 2018 to address accident and traffic enforcement concerns that focused on the MacArthur Road corridor and problematic secondary streets of the Township.

I am hereby recognizing the Whitehall Township Police Officers for their commitment to the community, as their efforts to reduce and prevent crime, as well as reducing and preventing reportable accidents, which have produced noticeable results in a short span of time.

The Criminal Investigations Division assigned 564 cases amongst the three detectives and one supervisor. The CID made 41 arrests and cleared an additional 126 cases. Overall, CID had a clearance rate for 2019 of 30%. With an average of 141 cases assigned per detective, per year, the detectives are doing an admirable job to maintain the clearance rate. An additional Detective was promoted to CID in February of 2020 in order to provide a better service to the community. In addition to the cases that they were assigned, the detectives were also tasked with background investigations for entry-level police candidates. In 2019, CID conducted twenty-two (22) background investigations, in addition to their assigned cases.

The Whitehall Police Department also participates in several, regional task forces to better serve the community and Lehigh County as a whole. One (1) Whitehall Officer serves in a full time capacity as a Vice Detective assigned to the Lehigh County Drug Task Force. One (1) Whitehall Officer serves in a full time capacity as an Auto Theft Detective assigned to the Lehigh County Auto Theft Task Force. Two (2) Whitehall Officers serve on a part time basis as Computer Crime Investigators with the Lehigh County Regional Computer Crimes Task Force. One (1) Whitehall Detective serves in a part time capacity with the FBI Safe Streets Task Force. Seven (7) Officers serve in a part time capacity with the Lehigh County Municipal Emergency Response Team. Six (6) officers are also assigned on a part time basis as accident reconstructionist with the Lehigh County CART (Crash Reconstruction Team). The police department also participates in the Blue Guardian program, which is a county-based program that hopes to reduce the effects that the opioid epidemic has had on Lehigh County.

In 2018, the Whitehall Police Department created a Police Explorer Post. The Police Explorers Post gives young adults an inside look at the field of law enforcement. The program is open to 14-20 year olds, who plan to pursue a law enforcement related career. The department also participates in the Project Lifesaver program, which helps police find people with Alzheimer's disease, autism or other cognitive problems who wander away from home. These individuals are fitted with an ankle bracelet containing a transmitter that emits an individualized locating signal. In the event that someone wearing a bracelet wanders away, the department can track them down quickly by homing in on the signal from the bracelet.

As safety and liability is an everyday concern in the police field, the Whitehall Township Police Department has dedicated itself to be at the forefront of police training in the Lehigh Valley. Forty-five (45) officers attended sixty-six (66) different trainings in 2019. The trainings were on variety of topics including crisis management, criminal investigations, forensics, accident investigation, patrol interdiction, police bicycle operations, school resource officer, advanced use of force training, supervisor courses, and mental health recognition and de-escalation techniques.

The members of the Whitehall Township Police Department are committed to maintaining a safer community in 2020 as we continue to focus our efforts on enhancing overall public safety and crime reduction.

TAX FRAUD

April is tax season and the Whitehall Police Department is prepared to handle any questions or concerns regarding matters of TAX FRAUD. Tax Fraud is a form of identity theft where someone has used your personal identification information to file for a fraudulent tax refund. Tax Fraud can be scary but we can get you started on the right path. Tax Fraud is a Federal Crime, which has risen in the last ten years to epidemic proportions. The Internal Revenue Service is constantly revising the way they deal with this type of Identity Theft. Check their website first should you discover your Social Security Number has been used to file a fraudulent claim.

It may be necessary to make a police report. Please do so at your earliest convenience. You can make the report in person or dial (610)-437-5252 and an officer will come to you.

Instead of Tax Fraud, you may get a phone call from someone claiming to be the FBI or IRS.

Please keep these things in mind:

- The FBI (Federal Bureau of Investigation) does not collect tax money.
- The IRS (Internal Revenue Service) will notify you by mail if you owe back taxes, not by phone or email.
- The IRS does not accept payment by Green Dot Card, Pre-paid Visa Card, iTunes Card, etc. They only receive payment by personal check and/or electronic transfer.
- The FBI does not receive direct payments for anything from citizens.
- Please verify the validity of any request made of you to send funds to anyone who demands it in the name of a Federal agency. Please call the police department if you have questions. It is better we have a chance to answer your questions than you become the victim of a scam.

TO REPORT AN EMERGENCY USE 9-1-1

9-1-1 should only be used for an emergency. An emergency is any life threatening situation including crimes, fires, traffic accidents, or any crime in progress or a serious crime which has recently occurred.

What to expect when you call 9-1-1

When you call 9-1-1 for an emergency, it is important that you remain calm and you are prepared to answer questions from the 9-1-1 emergency dispatcher. The "who, how, what, when and where" of the emergency situation are extremely important. It may seem these questions are unnecessary; or may not make sense to you at the time, but the details of the incident may be crucial to successfully resolving the emergency. You can help by providing brief accurate answers. Your patience will help process the emergency call and get help to you as quickly as possible.

For non-emergency contact you call the dispatch center at (610) 437-5252

All non-emergency calls for service are routed through the Lehigh County Communications Center and dispatched to the members of the Whitehall Township Bureau of Police. All citizen phone calls are viewed as important and residents should never be reluctant to place the call. Telephone callers may remain anonymous if they so choose.

REFUSE AND RECYCLING

Waste Management will continue to be the hauler of garbage, recycling, yard waste, grass and leaves for Whitehall Township in 2020. **If any of your collections are missed, please call the Township at 610-437-5524, ext. 139 or 100.**

Waste Management has a website with information for Whitehall Township residents. Residents can reach the site

through WM.com or a Google search. Customer service reps will also have the ability to assist residents with issues by utilizing the same site.

TOWNSHIP REFUSE CART

The designated Whitehall Township refuse automated cart is the **ONLY** container that will be picked up at the curb. **NO loose garbage or garbage in any other container will be picked up.**

Bulk Item Collection – residents are allowed two (2) bulk items, e.g. mattress, sofa, etc., can be placed at the curb each week on your regular collection day.

Pick-up of any appliance containing Freon, CFC or HCFS, can be put at the curb for pick-up on the **4th Wednesday of each month** after paying a \$25.00 at the Township Tax Office.

Pick-up for any Non-Freon appliance or “White Goods”, e.g. washer, dryer, hot water heater, etc., can be placed for a monthly curbside collection on the **4th Wednesday of each month** after calling 610-437-5529 to get put on the monthly list for pick-up.

TOWNSHIP RECYCLING CART

The designated Whitehall Township automated recycling cart is the only container that will be picked up at the curb. **NO LOOSE** recycling or any other container will be picked up. Excessive recycling can be taken to the Township’s Recycling Center on Range Road.

COMMERCIAL RECYCLING

Pennsylvania Act 101 and Whitehall Township require that businesses, professionals, non-profit organizations, institutions, and industrial and residential landlords must recycle plastics containers, #1-7, glass bottles and jars, newspapers, office paper, magazines, junk mail, phone books, cardboard, and yard waste. It further requires that you report your recycling information to the Township each year by February 1st.

RECYCLING OR TRASH CARTS

If you are new to the Township and have bought an existing home, the trash and recycle carts should have been left with that home. If not, call the Municipal Building at (610) 437-5524 and report it. If you have moved into a newly built home, use the same telephone number to contact the Township and carts will be delivered after a moving permit is purchased.



REMINDER TO PROPERTY OWNERS: NEW FOR THE YEAR OF “2020”

******ALL YARD WASTE, GRASS & LEAVES WILL NOW GO OUT THE DAY AFTER YOUR SCHEDULED TRASH COLLECTION DAY******

- Yard waste (shrubs, hedge clippings, weeds, tree branches (no longer than 4 ft. in length) cannot be

mixed with regular garbage and are collected on the day after your garbage day beginning the first full week of March until the last full week of November. Please keep lids off of those containers so they can be distinguished from the regular garbage.

- **Grass** collection starts **April 6th** and transitions into **leaf** collection and ends **November 30, 2020**. Grass and leaves can be mixed together between October-November.

HOLIDAY CURBSIDE COLLECTIONS

When a holiday falls anytime during a **work week**, there will be no pick-up on the holiday and it will push **ALL** collections to the next day(s) for the week.

This applies to:

- Memorial Day, Monday, May 25, 2020
- Labor Day, Monday, September 7, 2020

MAKING SENSE OF INVESTING

COLLABORATIVE EFFORT FOR IMPROVING OUR STREAMS

A 600 ft. section of the Coplay Creek that runs along the Prydun Farm is in the design phase for some restoration. This section, along with many of our streams, have bank erosion from increased stormwater flows, they lack natural cover and manmade obstructions creating poor fish habitat. Barren stream beds with sediment deposits is like a desert to native Trout and the bugs they eat. This project is a step in the right direction to help restore streams close to their once natural state. It all started with a study that was funded by Cold Water Heritage Partnership and PA DEP. Supporting partners include PA Fish and Boat Commission, Trout Unlimited and the Townships of Whitehall and North Whitehall. The study identified the areas that are in good condition along with the ones that need restoration. American Engineers Group, LLC was selected after a public bid to come up with a design to improve this section of the stream.



In late February, a conceptual plan was submitted and reviewed by the Township and Trout Unlimited Volunteers. Through one of the Trout Unlimited very active and knowledgeable members, Fish and Boat existing Fish Habitat improvement recommendations were obtained and are being plugged into the project. Trout Unlimited has been involved with other successful projects along the Coplay Creek in Whitehall and throughout the region. Township Real Estate Bills and Garbage Fees are due in the flat amount by June 30, 2020. From July 1, 2020 to December 31, 2020 bills are due in the penalty amount.

FAILURE TO RECEIVE A BILL DOES NOT ENTITLE OWNER TO DISCOUNT OR REMISSION OF PENALTY TAXES OR GARBAGE FEES.

Senior discounts (any individual over 72 years old by December 31, 2019 and a homeowner residing in Whitehall or a lifetime tenant) and total exonerations (total household income under \$15,000 meeting the criteria) can only be applied for at the Tax Office. Proof of age is required for the senior discount. Proof of income for total exoneration must be submitted along with a (PA-100) property rebate form.

PLEASE REMEMBER MORTGAGE COMPANIES DO NOT PAY GARBAGE BILLS.

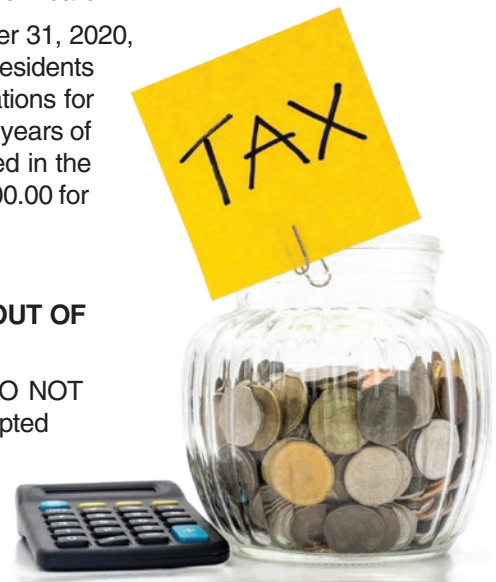
School Real Estate Tax Bills will be mailed by July 1, 2020. Taxpayers have the option of using the installment payment plan which has the first payment due by **AUGUST 10, 2020**. The amount due is based on the flat amount. Millage will be available by the end of June 2019 when established by the Whitehall-Coplay School Board.

Per Capita Bills will be mailed by July 1, 2020. Bills must be paid by December 31, 2020. Any delinquent bills will be collected by G H HARRIS Collection Agency. All residents between the ages of 18 and 72 are required to pay a Per Capita bill. All exonerations for the 2020 Per Capita bill must be submitted by December 31, 2020. Taxpayers 72 years of age by June 30, 2020 and active military personnel are exonerated. Also included in the exonerations are full time college students for Fall of 2019 with income below \$5,000.00 for tax year 2018. Proof is required and needs to be submitted.

BUSINESS PRIVILEGE TAX IS DUE BY JUNE 1, 2020.

A MOVING PERMIT (with a \$5.00 fee) IS REQUIRED TO MOVE IN, MOVE OUT OF OR WITHIN WHITEHALL.

PLEASE NOTE: We accept cash, check or money order for payments. We DO NOT accept debit or credit cards. When making a payment by mail, a postmark is accepted as an on-time payment. If you wish to make a payment after-hours, there is a secure lock box located to the right of the main entrance doors to the Municipal Building. Tax payment also accepted at Fulton Bank (**Whitehall Branch only**).

HOME CONSTRUCTION PROJECTS

Planning a new construction project on your home this spring/summer? Please know that several items regarding your project may have changed over the past year. For example, any new residential addition or new construction project will, as of MAY 1, 2020 require the submission of THREE (3) sets of plans for your project. Any other type of residential construction typically requires two (2) sets. In addition, there have been more updates and changes to the deck construction regulations which may affect your project. It is always a safe and good idea to check with the Township regarding your project prior to commencing same so that you don't get any surprises at time of permit submission. Many helpful guides are located on the township's website at www.whitehalltownship.org; and for more specific construction questions you can call the Township's code inspection agency, Keycodes Inspections 610-866-9663.



Spring And Summer Did You Know??

Did you know?

Any growth on your property can **not** extend into the public right of way or cause an obstruction to passing pedestrians or motorists. This includes the 'alley out back'. All growth must be maintained entirely on the owner's property. Street trees must be maintained at a minimum height of 8 feet over the sidewalks and 14 feet over the street, and no growth can obstruct traffic signs. In addition, your grass cannot exceed 15" in height. It is important to note that the township does not regulate growth between properties, and any trees or shrubs that extend from your neighbors property onto yours are a civil matter between the two of you to resolve.

Did you know?

You can **not** park your vehicle (with the exception of the boat or rv or trailers for same) on the grass of your property. All vehicles must be parked on a **paved** surface. In addition, if there are concrete sidewalks abutting your property, all driveways or parking areas (even for the boat or rv) must be accessed with an approved concrete apron.

Did you know?

Standing water still breeds mosquitoes – and now some 'new' exotic disease carrying types like the asian tiger....and the west nile virus! Therefore, you are required to eliminate any standing water on your property. This also means that you cannot store tires outside (which are frequently the highest incidence of standing water for mosquito breeding). Remember to check your plant pots too! These are excellent mosquito breeding environments.



Did you know?

Only certain types of businesses may be run from the home.... Those that do not in any way alter the character of the neighborhood. For more information on what is allowed and what is not, contact the zoning office at 610-437-5524 x155.

Did you know?

The federal NPDES (national pollutant discharge elimination system) regulations trickle all the way down to **you** as an individual property ownerand regulate any discharges you have on your property into the public storm sewer system. This means that no mud or debris can leave your property and be deposited in the roadway (not to mention the fact that this is considered *litter* and you could be cited by the police for littering!!!) – this includes if you are having work done on your property that involves excavation or landscaping. In addition, neither you nor your contractor can use the public rights of way – streets or alleys – for storage of landscaping or building materials. This too is litter and could end up in the storm drains. No mulch, stone, or other items can be deposited in the street. Keep it on your private property, and during construction make certain you or your contractors are not dragging or causing soil or mud to exit your property into the street. Clean water benefits all of us!

Did you know?

If you are having a property line dispute with your neighbor you will need to consult with an attorney. The Township will not and actually cannot adjudicate disputes of property lines, this can only be done by a judge. In addition, the Township cannot locate your property lines for you. You will have to contract with a private licensed professional land surveyor for this service. It may seem like a costly investment, but it is of great benefit to you to have the knowledge of where your property lines are.

Did you know?

All of the Bureau's forms and permit applications can be accessed on the Township's website – www.whitehalltownship.org. However, please know that all permits must be submitted on hard copy either in person or via mail to the Township. In addition, if you have a contractor doing your work, **they** must be the permit applicant, as they will be required to be responsible for their work by securing the appropriate business license and providing proof of workmen's compensation insurance.

The Whitehall Township Fire Department has instituted a Commercial Fire Inspection Program. We have hired a Fire Inspector to assist with these tasks. Lack of staff has required us to be reactive with our fire inspections. With the new Fire Inspector, we will become proactive. We will inspect properties subject to our property maintenance fire code. Though many commercial properties are well maintained, substantial numbers have evidenced dangerous conditions. Examples are extension cords run from one side of the building to the other; taped open fuses in a panel box; emergency exits blocked or improper hardware or placement of hardware. We hope to mitigate these types of issues and make the buildings safer for owners, employees and customers. The cost of inspections will be square footage dependent.

The Whitehall Bureau of Fire is a combination Fire Department with a career Fire Chief and a volunteer staff. The department operates out of five stations: Fullerton, West Catasauqua, Hokendauqua, Egypt and Cementon. We have a staff of approximately one hundred volunteers. Of those volunteers fifteen are Honorary Firefighters – retired members that still assist with fundraising and education our newer members regarding firefighting tactics and operations. Of the eighty-five remaining, on an average of fifty-seven members respond on a regular basis. Of the fifty-seven, thirty-two are qualified as interior firefighters. The remaining thirty-five are exterior Firefighters or Drivers.

This information is illustrative of what is taking place across the United States. The decline of the volunteer Firefighters is real. Ten years ago, the state of

Pennsylvania had Three-Hundred thousand volunteers in the state. Currently, the state has under thirty-thousand volunteers. The thirty-two interior Firefighters that we have spread out among five stations, gives an average of six firefighters per station. On an average structure fire call, we need twenty-six interior firefighters within the first ten minutes of the fire. Fire grows at a rate of four times a minute in heat. Our department is faced with the same issues that all volunteer departments are having -recruitment. Our average interior firefighters age is forty-two to fifty. Without a steady resource of new younger firefighters, our department is in peril. In ten years, our interior Firefighters will be of the age of fifty-two and sixty with a reduced number of interior firefighters.

WE NEED VOLUNTEERS. It has become difficult to obtain younger Firefighters. They are at the age where they are getting ready to go to college or obtaining their first jobs, starting their careers, or moving out of their parents' homes and moving out of the area.

In order to assist in looking for all possibilities to aid with these issues, we have partnered with other local Fire Departments with the same issues and have applied for a regional grant in order to have a survey from an outside resource to look into our operations, facilities and equipment for our department.

PLEASE NOTE:

Whitehall Bureau of Fire would like to remind our residents that the only outside burning allowed is a natural gas / propane fed fire. The flame cannot be any taller than eighteen inches in height. Any resident caught burning is subject to a citation and fine.
